4. About Our Organizational Reform

Hitachi Metals introduced the internal companies in FY 2001 to enhance autonomy and speed of decision making in each business. We have also executed various M&A deals and business structure reforms to promote growth. Meanwhile, as the market environment and customer needs change dramatically, it becomes more important to accelerate the continual change of our portfolio through selection and concentration more than ever, as well as to combine the specific technologies our company has and to strive for growth through co-creation with our customers.

Therefore, as of April 1, 2019, reform the internal companies into the business divisions, Hitachi Metals will reconstruct our organization to enhance synergy among our businesses while centering around the markets and businesses our company will focus on well into the future. Moreover, we will enhance crosscutting functions in order to execute the organizational reform that strives to enhance both our strategies and governance.

The following describes the details of our initiatives.

[Overview of the Organizational Reform]

1. Reform the 4 Internal Companies into 2 Business Divisions

Hitachi Metals will introduce the business division structure, in consideration of the market and customer needs as well as commonality and synergy of our underlying technologies.

(1) Advanced Metals Division

It will develop businesses that target the markets for engines, automobiles, transportation equipment, and electronic materials while centering around melting and casting technologies. It will consist of the businesses currently belonging to Specialty Steel Company (except for Soft Magnetic Materials and Components Business Unit) and Functional Components Company.

(2) Advanced Components and Materials Division

It will develop businesses that target the markets for xEV*, electronic components and industrial infrastructures while centering around assembly technologies. It will consist of the businesses currently belonging to Magnetic Materials Company, Cable Materials Company as well as Soft Magnetic Materials and Components Business Unit at Specialty Steel Company.

* xEV:Term referring to Electric Vehicles (EV), Hybrid Electric Vehicles (HEV), and Plug-in Hybrid Electric Vehicles (PHEV).

2. Enhancement of cross-cutting functions

Hitachi Metals will reinforce the Corporate Administration Divisions and revitalize personnel exchanges among business divisions in order to accelerate the improvement of business operations and management as well as the effective use of resources.
