Hitachi Cable overseas subsidiary to withdraw from the manufacture and sale of vinyl-insulated wires for automobiles

Hitachi Cable, Ltd. has announced that its Philippines subsidiary, Hitachi Cable Philippines, Inc., will withdraw from the manufacture and sale of vinyl-insulated wires for automobiles, or automotive wiring, effective October 31, 2006.

Hitachi Cable Philippines will focus its resources on the manufacture and sale of officeequipment rollers and other products.

1. Reasons for withdrawal from this business area

Established in July 1997, Hitachi Cable Philippines currently manufactures and sells office-equipment rollers for use in printers and other products, in addition to automotive wiring . Recently intensifying competition in the automotive-wiring market in the Philippines has led to projections of declining profitability for Hitachi Cable Philippines' automotive-wiring operations.

Seeking to restructure its core business, or wires and cables business, the Hitachi Cable Group is currently seeking to achieve optimal production, higher efficiency, cost reductions, and other improvements groupwide. As part of its efforts to focus resources on selected areas, it has decided to cease Hitachi Cable Philippines' automotive-wiring business, effective October 31, 2006, based on projections of decreased profitability.

3. Future projections

Withdrawing from this line of business is projected to result in extraordinary losses of approximately 700 million yen in the 2007 fiscal year.

Since these extraordinary losses fall within the range of consolidated business performance projections for the fiscal year ended March 2007, as announced with the settlement of accounts for the first quarter of the fiscal year (July 28, 2006), no changes will result in the values of these projections.
