3. Reasons for the differences from business performance forecast

Net sales for Hitachi Cable, Ltd. for the fiscal year 2009 (April 1, 2008 - March 31, 2009) mainly agree with those given in the previous forecast.

However, the Company's operating income and ordinary income outdid the previous forecast due to an improvement in the profits of semiconductor-related products over those anticipated, and a better-than-expected inventory revaluation loss, owing to favorable copper price movements.

Net income and net income per share were slightly below the previous forecast due to the recording of extraordinary losses resulting from the implementation of restructuring measures.
